With effect from the Effective Date, the Fund may invest 30% or more (which percentage may vary from time to time at our discretion) of its asset value into each of the following underlying funds managed by us:

- LionGlobal Singapore Trust Fund
- LionGlobal Short Duration Bond Fund
- LionGlobal Singapore Fixed Income Investment (a sub-fund of LIONGLOBAL TEAM)
- LionGlobal Singapore Investment Grade Bond Fund (a sub-fund of LionGlobal Investment Funds II)

For the avoidance of doubt, the changes will not result in any change to the investment objective and focus of the Fund.

Please be assured that no action needs to be taken on your part and your unitholdings in the Fund remain unaffected by the changes above.
