Changes to the Benchmark Disclosures within the Prospectus for the sub-funds (the “Funds”) of M&G (Lux) Investment Funds 1 (the “Company”)

M&G (Lux) 投資基金(1) (下稱「本公司」) 之子基金 (下稱「基金」) 之公開說明書中績效指標揭露之變更

Defined terms used in this letter have the same meaning as in the Prospectus, unless otherwise defined hereafter.

除非下文另有定義，否則本函中使用之定義詞彙與公開說明書中之意涵相同。

Effective from Friday 14 February 2025 (the “**Effective Date**”), we will be making changes to the way benchmarks are disclosed in the Prospectus to provide standardisation and consistency across M&G documentation.

自 2025 年 2 月 14 日 (「**生效日期**」) 起，我們將對公開說明書中績效指標揭露之方式進行變更，以確保 M&G 文件之標準性及一致性。

Each Fund’s performance is assessed against a benchmark (usually a representative index or reference rate, which is a benchmark used to set interest rates in a specific currency) denominated in its Reference Currency. The benchmarks are used solely to measure the Funds’ respective performances and does not constrain the Fund’s portfolio construction.

各檔基金之績效均根據以其參考貨幣計價之績效指標（通常為具代表性之指數或參考利率，作為用於設定特定貨幣利率之基準）進行評估。這些績效指標僅用於衡量基金各自之績效，並非限制基金之投資組合架構。

From the Effective Date, the Prospectus will continue to list each Fund's benchmark corresponding to the Share Classes denominated in the Fund's Reference Currency, but for Hedged Share Classes and Share Classes denominated in currencies other than a Fund's Reference Currency, benchmarks will be available on the M&G Website www.mandg.com/benchmarks

自生效日期起，公開說明書將持續列出與以基金參考貨幣計價之股份級別相對應之各基金績效指標，但對於避險股份級別及以基金參考貨幣以外之貨幣計價之股份級別，將於 M&G 之網站 www.mandg.com/benchmarks 提供績效指標

In order to reflect this, each Fund's Benchmark disclosure within the Prospectus will be updated. In the case of M&G (Lux) Episode Macro Fund, the wording in the benchmark disclosures referring to the cash indices used as the Performance Fee Hurdle Rates per currency will also be removed, although information on the benchmarks used in the performance fee calculation of the Fund will continue to be included in the 'Performance Fee' section of that Fund's Supplement.


