CORRUPTION PERCEPTIONS INDEX



 - (a) Searching method (taking the counterparty's locations in the R.O.C. as an example): It is advised to query in the "Ministry of Labor Inquiry System for Public Institutions (Employers) Violating Labor Laws "system(https://announcement.mol.gov.tw/), enter the "name of the institution" and "date of penalty" to select a period from the query date to the past year, then the results of the penalties by searching keywords in the past year will appear. If there are many cases, you can check whether there are words such as "employment of child labor", "human trafficking" and "forced labor" in the content which violates laws and regulations.
